Former Delhi BJP president and MP Manoj Tiwari also addressed the gathering. He claimed that the incident at the AI Summit was not an ordinary protest but a sign of frustration within the Congress party.

He said representatives from more than 80 countries attended the summit and that it was an event of national importance.

Tiwari alleged that even before the police intervened at the summit venue, members of the public present had objected to the disruption. He said the Congress could not tolerate India's growing global stature in the field of artificial intelligence and technology.

Several MPs, MLAs and municipal councillors were present at the protest. State office-bearers and district presidents of the party also joined the demonstration. The gathering remained largely peaceful until protesters pushed past barricades placed by the police.

The BJP leadership accused the Congress of attempting to defame India in international forums.

Kapil Mishra inaugurates development projects

Delhi Minister Kapil Mishra on Saturday laid foundation stones and inaugurated several development projects in Karawal Nagar, asserting that infrastructure growth in the national capital will now "accelerate further" after what he described as a year of administrative correction.

Mishra, who holds the portfolios of Art, Culture and Languages, Tourism and Labour and is also in-charge of North-East Delhi, said that governance systems have been brought back on track over the past year. He claimed that residents across the city are welcoming what he called a shift towards service-oriented and accountable administration.

Speaking at Karawal Nagar, the Minister said that areas in Yamunapar and rural Delhi had suffered from neglect in the past, with even basic infrastructure left unattended. He alleged that earlier governments lacked clear policy direction and intent, which slowed development despite Delhi being the national Capital.

Highlighting recent measures, Mishra said a new drainage master plan worth over ₹50,000 crore has been

prepared after nearly five decades. He added that more than 2.2 million metric tonnes of silt have been removed from major drains across the city. He said projects worth ₹9,000 crore are underway to strengthen sewer connections and water supply systems and to support the rejuvenation of the Yamuna. In addition, development schemes worth ₹723 crore have been approved specifically for Yamunapar areas, he said.

During the visit, Mishra laid the foundation stone for construction of an RCC road from Baba Dayala Chowk to

Gali number 06 in Sadatpur Extension in Dayalpur village. He also laid the foundation for another RCC road from the main market of Karawal Nagar village to Lal Bagh Mandi. These projects, he said, will improve connectivity and ease daily movement for residents.

The Minister also inaugurated the reconstruction of a culvert over the Tukmirpur drain. The project aims to improve drainage and reduce waterlogging during the monsoon season.

In addition, construction work was initiated for a new culvert over a drain at Kali

Mishra said development projects worth over ₹300 crore have already been initiated in Karawal Nagar over the past year. He added that several new initiatives aimed at balanced and comprehensive development of the constituency will begin this year.

He said the Chief Minister and Cabinet ministers are regularly engaging with residents through public grievance forums.

According to him, suggestions received from citizens are being incorporated into Government schemes.

Mishra said that with public cooperation and participation, efforts are being made to transform both Delhi and Karawal Nagar into developed regions. He asserted that development will now move at a faster pace across all constituencies of the Capital. The Minister's visit comes amid a broader push by the Delhi Government to highlight infrastructure upgrades and civic projects in outer and trans-Yamuna areas, which have historically raised concerns about inadequate facilities and slow execution of works.

Play for the National Team: Speaker tells youth

Delhi Assembly Speaker Vijender Gupta on Saturday called for a shift in political culture from individual ambition to collective responsibility, saying India's journey towards becoming a developed nation by 2047 would become "unstoppable" when leaders start playing for the "National Team".

Addressing the inaugural session of the 15th Indian Student Parliament (Bharatiya Chhatra Sansad) in New Delhi, Gupta said politics must learn from sports, where victory belongs to the team and not to an individual. He was speaking on the theme, "From Stadium to Statesmanship: What Can Politics Learn from Sports?" "In sports, victory belongs to the team. In politics, the true victory must belong to

the people," Gupta said, urging young leaders to imbibe discipline, teamwork and sportsmanship in public life.

He said the playing field is a powerful classroom for leadership. Just as an athlete works tirelessly to uphold the Tricolour, a public representative must serve with selfless devotion to protect the nation's dignity, he added.

Gupta described discipline, teamwork and sportsmanship as the three pillars that can bring fresh energy into modern politics. In a democracy, he said, the Constitution is the ultimate rulebook, much like the laws of a game. He asked the youth to treat political opponents as "competitors" and not "enemies". Accepting defeat with grace and respecting the winner is the foundation of a progressive society, he said. "A captain is tested in a crisis.

Similarly, a leader's true character is seen when the nation faces challenges," he added.

Speaking about the goal of Viksit Bharat @2047, Gupta said India can achieve developed nation status only if young people bring honesty, focus and merit into governance. He stressed that a developed India requires a political culture where merit is the only yardstick and

manipulation gives way to dedication.

Breaking barriers of religion, caste and region is essential to build one national team, he said. Such unity, he added, will help India stand on the global podium as a leader across sectors.

Aligning his remarks with the vision of Prime Minister Narendra Modi, Gupta said the Viksit Bharat initiative is

not merely a policy but a national movement powered by youth and technology. He said governance today must embrace digital innovation to ensure justice and opportunity reach the last person in the queue.

Drawing a parallel with modern sports analytics, he said governance must use digital tools to improve performance and transparency.

In his concluding remarks, Gupta urged students to treat failure not as a "full stop" but as a "comma", an opportunity to improve and return stronger. He praised the Bharatiya Chhatra Sansad for nurturing character and integrity among young citizens. Reiterating his core message, the Speaker said when leaders stop playing for themselves and start playing for the nation, India's rise as a global champion will be certain.
